OUR MISSION IS TO PUT CHRISTIAN (CONTINUED ON SCHEDULE O)

THE YMCA IS A LEADING VOICE ON HEALTH AND WELL-BEING. WE BRING FAMILIES CLOSER TOGETHER, ENCOURAGE GOOD HEALTH AND FOSTER CONNECTIONS THROUGH FITNESS, SPORTS, FUN AND SHARED INTERESTS. IN 2019 WE PROVIDED \$245,097 IN DIRECT FINANCIAL ASSISTANCE AND PROGRAM SUBSIDIES TO FAMILIES, ADULTS AND CHILDREN PARTICIPATING IN YMCA PROGRAMS THROUGH HEALTHY LIVING. THESE PROGRAMS INCLUDED FITNESS CLASSES, CPR AND FIRST AID, LIFEGUARD TRAINING, AQUATIC EXERCISE, SWIM LESSONS FOR ADULTS, SENIOR FITNESS AND INDOOR CYCLING. THE NATURE OF THESE PROGRAMS IS TO PROMOTE ONE'S OWN SELF WORTH BY EMPHASIZING SKILL ACQUISITION & DEVELOPMENT, SAFETY, COOPERATION AND SELF CONFIDENCE, LEADERSHIP & TEAMWORK. IN 2018 WE ADDITIONALLY PROVIDED \$129,250 IN DIRECT SCHOLARSHIPS SERVING 1.275 INDIVIDUALS THROUGH OUR SCHOLARSHIP PROGRAM WHICH INCLUDES CHILD CARE, YOUTH PROGRAMS, AND MEMBERSHIP. (CONTINUED ON SCHEDULE O)

THAT'S WHY WE HELP YOUNG PEOPLE CULTIVATE THE SKILLS, VALUES AND RELATIONSHIPS THAT LEAD TO POSITIVE BEHAVIORS, BETTER HEALTH AND EDUCATIONAL ACHIEVEMENT. OUR AFTER SCHOOL AND SUMMER CAMP CHILDREN HAVE WEEKLY PROGRAMS WITH OUR LOCAL LIBRARY AND MUSEUM WHERE THEY IMPROVE THEIR READING ALONG WITH PARTICIPATING IN OTHER ENRICHMENT OPPORTUNITIES.
